### Purpose Statement

This corporation is a **religious corporation** and is not organized for the private gain of any person. It is organized under the Nonprofit Religious Corporation Law exclusively for religious purposes.

The specific purpose of this corporation is to Promote unselfish living by developing, teaching, and organizing a particular way of life and belief system.

This corporation is organized and operated exclusively for **religious** purposes within the meaning of Internal Revenue Code section 501(c)(3).

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on behalf of any candidate for public office.

The property of this corporation is irrevocably dedicated to the purposes set forth herein and no part of the net income or assets of this corporation shall ever inure to the benefit of any director, officer or member thereof or to the benefit of any private person.

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operated exclusively for charitable, educational and/or religious purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).

# IdeaFarm Operations, Incorporated ATTACHMENT TO ARTICLES OF INCORPORATION

## ADDITION TO PURPOSE STATEMENT:

**Article A-1:** This corporation's overall mission and purpose is to promote unselfish living, defined as being wholesomely connected with other people, the Earth, and Higher Power.

## ADDITIONAL STATEMENTS:

**Article A-2:** This corporation is organized and operated exclusively for a religious purpose. Its operations will include literary and educational operations pursuant to that religious purpose.

**Article A-3:** Also pursuant to that religious purpose, the scope of this corporation's operations will include operations reached by U.S. Code 501(c) (4)-(7), either directly or through subsidiaries, such as:

- 1. Civic leagues operated exclusively for the promotion of social welfare.
- 2. Labor organizations (education and networking but not collective bargaining).
- 3. Business leagues.
- 4. Clubs organized for pleasure, recreation, and other nonprofitable purposes.

Article A-4: This corporation pursues the religious purpose described in Article A-1 (1) by developing and teaching a way of life, including a way

**of thinking** about Higher Power that is friendly to, and compatible with, all of the major world religions, and (2) by organizing "villages" of people who come together committed to this way of life.

**Article A-5:** This corporation is organized and operated exclusively to:

- 1. Speak, teach, and organize to promote unselfish living, without aligning with or favoring any particular religious, political, or other organization.
- **2. Teach and organize** to promote literacy and other basic life skills that natural persons need to participate in, and fully benefit from, the other operations of this corporation.
- **3. Operate an economic association for unselfish people** to empower people economically through education and networking (but not collective bargaining), thereby creating an economic incentive to choose unselfishness.
- **4. Facilitate the organization of unselfish people** by other entities for civic participation and lawful civic activism, to empower unselfish people politically.
- **5. Organize social events** to network people committed to living unselfishly to empower them personally, including mating and raising children.
- **6. Speak and teach to promote religious faith** according to any system of theistic or atheistic belief and practice that promotes unselfishness.
- 7. Operate primary, secondary, college, and university educational institutions to provide general education presented in the context of the

"way of life" and "way of thinking" of Article A-4.

**Article A-6:** "Religion" means any theistic or atheistic system of belief and practice that promotes a concept of Higher Power (not a person or government or other human organization) to which human beings are dependent upon or controlled by.

**Article A-7:** "Wholesome connection to another person" means a connection that is mutually beneficial and not harmful to the community or to human society generally.

**Article A-8:** "Wholesome connection to the Earth" means stewardship to exploit, enjoy, and develop the Earth, including all sentient beings, sustainably or otherwise ethically.

**Article A-9:** "Wholesome connection to Higher Power" means that a person sees himself or herself as nothing but a part of something larger, that life is about that larger thing, not about self, and that his or her purpose and duty is to live in a manner that promotes that larger thing, as a **normal cell** does in a human body, in contrast to a **cancer cell** or a **virus**.

**Article A-10:** This corporation will be friendly to, and partner with, other religious organizations, but will not align itself with any in particular.

Article A-11: This corporation will be friendly to, and partner with, civic and political organizations, but will not itself be a civic or political organization. This corporation will not align itself with any particular political party, and will not organize for civic activism, other than to facilitate and encourage civic participation according to individual choice.

**Article A-12:** This corporation shall be operated in a manner that empowers unselfish people to control the course of their own lives, but shall not itself become a concentration of power, or a voice for any idea other than

unselfishness (including the "way of life" and "way of thinking about Higher Power" of Article A-4), or an influence within society in any way other than to organize and empower persons who choose to live unselfishly.

**Article A-13:** This corporation shall have natural person members.

Article A-14: The Bylaws, and these Articles, shall not be amended without the consent of the incorporator, until such time as this corporation has at least 256 members and then has held elections in which at least 256 votes have been cast, for each director position, to confirm or replace the incumbent. This consent requirement shall survive and control notwithstanding the death or incapacity of the incorporator.

**Article A-15:** This corporation shall be controlled by the incorporator, then by a board of directors initially appointed by the incorporator and subsequently elected by its members. This control shall be subject only to these Articles, the Bylaws, and applicable law.

**Article A-16:** This corporation shall commence operations immediately, with the incorporator serving provisionally in all officer and board positions until such time as the incorporator selects members (or others) to take those positions.

Article A-17: Articles A-1 through A-17 shall not be amended.

Article A-18: Upon dissolution, this corporation's assets remaining after provision for payment of all debts and liabilities, shall be held by a bona fide fiduciary trustee for up to two years for delivery, with the consent of the incorporator if not incapacitated, to a successor incorporated with essentially the same business type and purpose. If that fails, the trustee shall select a similar U.S. nonprofit willing to resume operations pursuant to these Articles. If no such recipient can be found with due diligence, then the trustee shall deliver the assets to a U.S. nonprofit corporation with a

business type and purpose that embraces, or at least does not work against, the purpose of this corporation, or, at the option of that recipient corporation, shall liquidate the assets and deliver the proceeds.
